

Application to Participate in the San Fernando Valley Art Club's Booth at the Simi Valley Street Fair May 12, 2018.

The Street Fair will be located on Simi Town Center Way from 9:00 a.m. to 5:00 p.m. We have one booth that will be shared by the members of our club. We will have to be there earlier than 9:00 am. to set up and we will be there after the show closes at 5:00 p.m. to take down the display. (The exact information will come later)

- *All SFVAC participants will handle their own sales. There will not be a sellers fee from the club.
- *All participants will follow the rules of the Simi Valley Street Fair. No driving on the street to unload. They suggest hand carts or dollies to get items from the parking lot to the booth space.
- *All work must be original to the member and not the work of any other person.
- *Work to be hung on walls of the space should be wired or have some type of hook for hanging and be no larger than 18 by 24 inches in size.
- *Work should be in good taste. (There will be children at the Fair)
- *All art work should be identified with your name and phone number, and Bin Art should be identified with your name and covered in plastic to protect it.

It is further agreed that this waiver release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and hold the above persons or

entities free and harmless from any loss, liability, damage, cost, or expense which may incur as a result of my death or any injury or any property damage that I may sustain while participating in said activity. I also understand that space fees are non-refundable. I understand that this is an outdoor event and that the Simi Valley Chamber of Commerce will not accept any responsibility for goods damaged due to inclement weather. I further understand that the vendors must make their own decision to set up or not to set up their display. I understand that no refunds will be issued for any reason. In addition, I agree to pay any and all penalties assessed upon completion of event (as noted above). Vendors may want to purchase own liability insurance for the event. This event is held rain or shine.
