## MEMBERSHIP

All applicants must be members of the San Fernando Valley Art Club **BEFORE** entering the show.

## TAKE IN/PICK UP

\*Take-in of work is Tuesday, September 11, 2018 from 10 am to 5 pm **ONLY**. No late entries will be accepted. All work must comply to show rules at intake. Only hand delivery.

\*Pick-up is Friday, September 28, from 10 am to 5 pm.

## ELIGIBILITY

\* Open to SFVAC members only.  
\*All work must be original, completed after 2013.  
\*No Supervised or copied work, no posters or prints.  
\* Work must be appropriate for family viewing.  
\*Maximum 2D work is 30 x 40 inches including the frame. Frames must have hanging wires (no saw tooth hangers).  
\* Watercolors, drawings, chalk, charcoal should have glass or Plexiglass. If over 18 x 24 inches in size, use Plexiglass only.  
\* All work must be dry, clean, undamaged and properly framed and/or presented with finished edges.  
\* Sculpture must have its own base and secure support. The size is limited to being placed on the top of a shelf.  
\* Work must remain on exhibit until the end of the show.  
\*All work must have a tag on the back to identify the Artist, Title, Size, Media and Price.

## SALES

Exhibited work will be considered for sale unless indicated NFS on the Entry form. The Carter Sexton staff will handle the sales and charge tax. The Carter Sexton fee is 20% of the sale price. After the show is closed Carter Sexton will mail to the artist of sold work the remaining 80% of the sale price.

## LIABILITY

Insurance is the artist's responsibility. The SFVAC and Carter Sexton cannot accept responsibility for loss, damage or theft.
